

Emissions reduction targets

In order to our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 138 tCO_2e by 20. This is a reduction of 20%

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2022 baseline. The carbon emission reduction achieved by these cannot be measured against the baseline due to the pandemic, so will be measured in 2024, the measures will be in effect when performing the contract

- Where possible move to virtual meetings via Microsoft Teams
- LED Lighting
- 100% fleet moved to EV
- Where work circumstances allow, employees given options to work from home to reduce commuting and office use.

In the future we hope to implement further measures such as:

- Support our landlord to move to 100% renewable electricity and build strategies for heating decarbonisation in our building.
- Ongoing promotion of remote working to minimise commuting.
- Engage with suppliers who commit to net zero.
